#### **Our Company**

GEM Motoring Assist is a company that is part of the Call Assist Group. We provide affordable products to suit the requirements of motorists.

#### The Financial Conduct Authority (FCA)

#### Which service will you receive from us?

You will not receive advice or a recommendation from us for Personal Breakdown Insurance. We may ask questions to narrow down the selection of products that we will provide details on. You will then need to make your own choice about how to proceed.

#### Whose products will we offer you?

We only offer products from single insurers.

#### What will you have to pay us for our service?

You will not be charged a fee by us for arranging Personal Breakdown Insurance.

We receive commission from the insurer which is a percentage of the total annual premium excluding Insurance Premium Tax. We may receive other income based on the profitability of our account from an insurer.

You will receive a quotation which will tell you about any other fees relating to any particular insurance policy.

We may also receive other income or commission from carefully selected third parties based on other or additional services you may choose.

## Are we covered by the Financial Services Compensation Scheme?

We are covered by the Financial Services Compensation Scheme (FSCS). You may be entitled to compensation from the scheme if we cannot meet our obligations. This depends on the type of business and the circumstances of the claim.

For claims against the insurers, 90% of the insurance claim is covered, with no upper limit. For compulsory classes of insurance, insurance arranging is covered for 100% of the claim, without any upper limit.
